The high quality Bourns<sup>®</sup> Model 3610A2 ADSL2+ / VDSL2 POTS splitters are designed to fit industry-standard Network Interface Devices (NIDs). These POTS splitters are optimized for high bit-rate video over ADSL2+ / VDSL2 applications. The series is ANSI T1.413 compliant, meets the requirements of ITU G.992.3 and G.992.5 and can be used in ADSL, ADSL2+, VDSL and VDSL2 applications. The Model 3610A2 POTS splitters accept the incoming combined voice & data service, filter off the voice (POTS) channel and provide a connection point for the DSL data services (ADSLx modem). In the event of power loss, the passive filter design allows for lifeline POTS service.

Bourns offers the Model 3610A2 POTS splitters in an industry standard footprint (binding post) which occupies only a single space in the NID. Fitted with screw terminals and flying leads, the 3610A2 units can be installed in minutes. When combined with a Bourns<sup>®</sup> Multi-Stage (MSP<sup>®</sup>) Station Protector, Sealed Switching Jack, and optional IDC expansion bridge, a complete ADSL2+ / VDSL2 solutions package is provided for the customer premises.





### **Product Dimensions**








DIMENSIONS: MILLIMETERS (INCHES)
